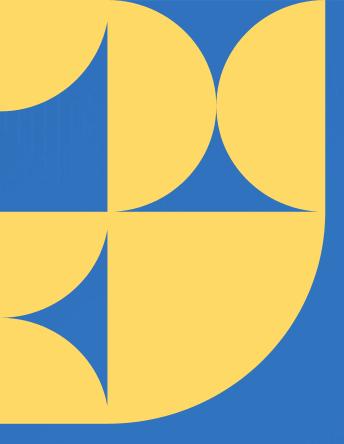
GSTIN - ADVISORY FOR ENTRY OF RR NO./ET-RRS IN EWB SYSTEM POST EWB-FOIS INTEGRATION

Applicability: Applicable to all taxpayers, suppliers, and businesses transporting goods via Indian Railways' FOIS.

The Freight Operations Information System (FOIS) of Indian Railways has now been integrated with the E-Way Bill (EWB) system through Application Programming Interfaces (APIs). This integration aims to streamline the process of transporting goods via rail, ensuring seamless data flow between both systems. Taxpayers and businesses utilizing Indian Railways for goods transport are required to follow specific guidelines for entering Railway Receipt Numbers (RR No.)/eT-RRs into the EWB system. Accurate data entry is crucial to avoid discrepancies and ensure compliance. Below are the key points for accurate RR No./eT-RRs entry.

- Integration of FOIS with EWB System
 The Freight Operations Information System (FOIS) of Indian
 Railways is now integrated with the E-Way Bill (EWB) system via
 APIs.
- Correct Entry of RR No./eT-RRs
 Taxpayers must ensure the correct entry of Railway Receipt
 Number (RR No.)/eT-RRs in the EWB system when transporting
 goods via Indian Railways.
- Updating Part-B of the EWB for Rail Transportation
 Suppliers must update Part-B of the EWB using the "Multi-Transport Mode" option and select Rail as the mode of transport.
- RR No./eT-RRs Format for FOIS
 The correct format for entering RR No./eT-RRs:
 F<FromStationCode><RR No> (e.g., FSJWT123456789).
- Validation Process for EWB and RR No./eT-RRs
 The EWB system will validate the entered RR No./eT-RRs against
 FOIS data. Mismatches will trigger an alert.
- Importance of Accurate Entry
 Accurate RR No./eT-RRs entries are vital to ensure smooth tracking, verification, and avoid delays or discrepancies in the transportation process.
- Support and Clarifications
 Taxpayers experiencing issues with entering RR No./eT-RRs should raise a support ticket for assistance.
- Compliance with Indian Railways Guidelines
 Customers using the Railway FOIS system must follow the guidelines issued by Indian Railways for e-Demand customers.
